### Key messages for removal of median barriers on Stage 1 of SH16 Brigham Creek to Waimauku improvements project as at 1 April 2025

#### General

- NZTA is committed to state highways that help people get where they need to go, safely and efficiently.
- Following a review of the safety interventions for Stage 1 of the SH16 Brigham Creek to Waimauku improvements project, NZ Transport Agency Waka Kotahi (NZTA) has decided not to proceed with the installation of median barriers between Huapai and Waimauku.
- This decision addresses the concerns we have heard from the community about property access
   and local travel impacts
- The project will complete widening bridges, creating wider road shoulders, installing the turnaround bays and installing a flush median.
- These interventions will improve the safety and efficiency of the corridor by creating more separation between lanes.
- The wider road shoulder will provide more space for pedestrians and cyclists, with increased accessibility for emergency services in heavy traffic.
- Turnaround bays will be utilised by our state highways maintenance teams and will be available as emergency stopping bays for emergency services and road users.
- NZTA will continue to monitor and assess safety and efficiency along the corridor. The upgrades we're completing now will provide space for additional safety interventions if required in the future.
- NZTA has determined this approach appropriately balances travel impacts for local journeys and safety for all road users.

#### Background

- State Highway 16 is an important link for the local community, as well as providing resilience within the wider Upper North Island state highway network. Over 15,000 vehicles travel this section of state highway every day, and this will continue to grow.
- The SH16 Brigham Creek to Waimauku improvements project has been split into two stages. Stage 1 runs from Huapai to Waimauku and Stage 2 is between the Brigham Creek roundabout and Kumeū.
- Construction in underway on the section between Huapai and Waimauku where there are slightly less complexities and where half of the crashes were head-on. Work will progress on this section while we continue to confirm aspects of the scoping, funding and design for Stage 2.

### Frequently Asked Questions

#### What is the difference between a flush median and median barrier?

A flush median is a marked area in the middle of a road that separates traffic and provides a place for turning vehicles. Median barriers are installed down the middle of a road to prevent head-on collisions.

#### What are the reasons for not installing the median barriers?

We've heard concerns from the local community and have noted general community feedback from other similar projects across the motu regarding median barriers. NZTA has sought to strike the right balance

between achieving better safety outcomes for all road users, while also allowing the community to get around efficiently.

#### Will the speed limit change along this section of SH16?

As part of the 2024 Setting of Speed Limits Rule the section of SH16 in Waimauku township will automatically reverse from 60km/h to 70km/h before 1 July 2025. The speed limit over the rest of the corridor project area will remain at 80km/h, with a temporary speed limit of 60km/h until construction of Stage 1 is complete.

#### What will the turnaround bays be used for now?

The turnaround bays will be utilised by our state highways maintenance teams and will be available as emergency stopping bays for emergency services and the road users.

#### Does this mean you are saving money? If so, will these funds be available for Stage 2?

We expect there will be some minor savings. Any remaining funds will be available for Stage 2 of the SH16 Brigham Creek to Waimauku improvements project or any other projects specified in the NLTP.

## What about those of us who supported the installation of median barriers – does this mean the road is now less safe?

NZTA has sought to strike the right balance between achieving better safety outcomes for all road users, while also allowing the community to get around efficiently. The safety benefits of a flush median are still expected to achieve a significant reduction in the risk of death and serious injuries (DSI).

#### Will the project finish earlier due to this change?

We expect there will be some minor time savings with the project finishing approximately 2 weeks earlier than planned.

## Will the median barriers be removed from Stage 2 of the SH16 Brigham Creek to Waimauku improvements project?

The median barriers included in the design for Stage 2 between Brigham Creek Road and Taupaki roundabout, will remain as they separate a dual carriageway.

## When can an announcement on Stage 2 of the SH16 Brigham Creek to Waimauku improvements project expected?

We are still working through internal processes to get a final decision on funding and scope. We appreciate the community have been patiently waiting for news on this. We will provide an update on Stage 2 as soon as a decision has been reached.
