## 7.2 Context

The Project has been informed by the following engagement activities that have been undertaken throughout the life of the Project:

- The Transport for Future Urban Growth (TFUG) Programme Business Case. In developing the
  programme business case two rounds of public consultation, stakeholder engagement and a series of
  hui with iwi across Auckland was undertaken. The feedback from these engagements was
  incorporated into the preferred programme, which recommended safety improvements on SH16 be
  prioritised for further business case investigation.
- The SH16 SSBC. Between 2016-2018, in developing the SSBC there was stakeholder, mana whenua
  and public engagement on options considered in the business cases, including specific public
  consultation on the SUP.
- Interim safety solution. In 2021 public feedback was sought on proposal to ban right turns from Coatesville-Riverhead Highway onto SN16 to improve safety while work continued on the Project.
- Detailed Design of SH16 Stage 2. Recent engagement undertaken in 2021-2022 has focussed on mana whenua partners, stakeholders and affected landowners where feedback was sought on the Stage 2 detailed design.

As discussed, I've done some digging to find sentiments about community and property owner sentiments about median barriers.

Some bullet points below, hopefully its helpful!



- o I did some more digging into the feedback received from landowners, it was two property owners (\$9(2)(a) SH16) and one or two others \$9(2)(a) that were opposed median barriers in front of their property and preventing right turns in/out of Kennedy's Rd. They were concerned that this would devalue their property (e.g. due to detour time) and about safety issues with barriers and motorcyclists. Another two property owners expressed some initial concern with median barrier.
- During Oct 2017 public engagement (which included stage 1 & 2) some people were concerned about median barriers as they were not sure if they are needed and wondered why they are in some areas and not others. Were concerned about getting in and out of driveways and where the turnaround areas are if they are put in. However, support for the proposed safety improvements was also noted (See 2017 feedback summary: <a href="https://www.nzta.govt.nz/assets/projects/sh16-brigham-creek-and-waimauku/SH16-Brigham-Creek-to-Waimauku-feedback-summary.pdf">https://www.nzta.govt.nz/assets/projects/sh16-brigham-creek-and-waimauku/SH16-Brigham-Creek-to-Waimauku-feedback-summary.pdf</a>)
- Amemo summarising the 2017 landowner information sessions noted that median barriers received "low support, especially in the section between Huapai and Waimauku. Local residents asked us to consider other options like a flush median and lower speed. Some of this concern was around 'corridor function' especially in relation to locally used large vehicles, access to bus stops, school bus, water deliveries, garbage and mail services."

I've haven't looked extensively in regard to Stage 1. I will keep looking but wanted to send you what I have so far since time is ticking.

## Stage 1:

Median Barrier: 3070m of wire rope barrier in five runs. Run 1: 860m, Run 2: 370m, Run 3: 680m, Run 4: 800m Run 5:360m

## Status:

Stage 1 is currently in Implementation with a physical works contract signed with Fulton Hogan to complete the works. The physical works are around 55% complete. Wire rope barrier installation is scheduled to start in June 2025 for the eastern section. The remainder is scheduled to be installed November/December 2025. Construction has begun on all the turning areas.

Considerations of removing the wire rope barrier:

- We have contractual commitment with Fulton Hogan we would need to break. Maximum potential saving would be \$320k
- Safety was the sole benefit of constructing stage 1 of the project \$9(2)(g)(i)

  Communications and engagement would need to be managed carefully around this and there could be some negative sentiment within the community.
- Three properties have been compulsorily purchased to construct turning facilities (2)(9)(1)
- The property owners of 601 SH16 took the project to the environment court in opposition to the NoR and turning facility on their property. They then took the project to an environment court assisted mediation under the PWA during the compulsory property acquisition. \$9(2)(g)(i)
